PROCEDURE TO PROVIDE FOR NOMINATION OF THE MEMBER OF MUNICIPAL COUNCIL OR MUNICIPAL CORPORATION ON THE SENATE, DIRECTION, 2022

Whereas, the Maharashtra Public Universities Act, 2016 (Maharashtra Act No. VI of 2017) (hereinafter the "Act") has come into force w.e.f. 1st March 2017, repealing the Maharashtra Universities Act, 1994;

AND

Whereas, the Act VI of 2017 has been made applicable to the Rashtrasant Tukadoji Maharaj Nagpur University Nagpur with effect from 1st March 2017;

Whereas, section 28 of the Act dealing with the composition of the Senate of the University provides for nomination of one representative of the Municipal Council and Municipal Corporation, by the Vice- Chancellor, for the tenure of one year, by rotation; AND

Whereas, the Statute No. 32 of 2010 dealing with the nomination of representative of Municipal Council or Corporation has become inconsistent with the provisions of section 28 of the Act and is therefore deemed to have been repealed;

Whereas, it is desirable to frame a Statute to lay down the procedure for determination of rotation of nomination of representatives of Municipal Council or Corporationon the Senate of the University;

AND

Whereas, making of the Statute is a time consuming process therefore Direction no. 4 of 2018 was issued on 15.2.2018 but the same could not be converted into a statute within six months of its issuance and therefore is lapsed on the expiry of said period.

AND

Whereas, the term of elected members of the Senate is over in 2022 and the process of election for constitution of new Senate is going on and the nominations to the authorities of the University is required to be completed by 30th of November and as such there is an exigency to issue a Direction;

Now, therefore, I, Dr. Subhash R. Chaudhari, Vice-Chancellor, Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur, in exercise of the powers conferred upon me under section 12(8) of the Act do hereby issue the following Direction:-

1. This Direction may be called "PROCEDURE TO PROVIDE FOR NOMINATION THE MEMBER OF THE MUNICIPAL COUNCIL OR MUNICIPAL CORPORATIONON THE SENATE, DIRECTION, 2022.

- 2. This Direction shall come into force with effect from the date of its issuance.
- 3. In this Direction, unless the context otherwise requires:-
 - (a) "Member of Municipal Council or Corporation" means a member of the Municipal Council or Corporationwithin the University area.
 - (b) "University" means Rashtrasant Tukadoji Maharaj Nagpur University.
- 4. Whereas as per the provision of section 28(2)(y) of the Act one member of the Municipal Council or Municipal Corporation, within the University area, is to be nominated on the Senate of the University by the Vice-Chancellor, for a tenure of one year, by rotation, and since there are several Municipal Councils and one Municipal Corporation within the jurisdiction of the University it is necessary to determine the point of rotation. Therefore, as there is only one Municipal Corporation within the jurisdiction of the University the nomination of the member for the first time, in the newly constituted Senate under the Act, shall be given to that solitary corporation.
- 5. In order to determine the subsequent rotation the Registrar of the University shall collect the information regarding various Municipal Councils in the four districts within the jurisdiction of the University as per entry 5 in Part-I of the Schedule to the Act and prepare list of the same, in the alphabetical order.
- 6. The Vice-Chancellor shall draw the lots and determine the sequence of the four Municipal Councils to be represented on the Senate of the University for the remaining four years of its tenure, unless the Senate is dissolved prematurely, for any reason.
- 7. The rotation for the Senate reconstituted after expiry of the tenure of the first Senate under the Act, or due to its premature dissolution, shall be similarly determined by draw of lots.
- 8. At least one month before the expiry of the term of the member of the Municipal Corporation or the Municipal Council, as the case may be, on the Senate the Registrar shall intimate to the CEO of the concerned Municipal Council/Commissioner, Municipal Corporation the nomination of its member, in the order in which the rotation has been determined under para 5 above.
- 9. If in future any new Municipal Council or Municipal Corporation is created, within the jurisdiction of the University, the same shall be added to the list of the Municipal Councils or Municipal Corporation prepared under para 5 above.
