Whereas, Maharashtra Public Universities Act, 2016 (VI of 2017) (here in after the Act) has come into force, repealing the Maharashtra Public Universities Act, 1994, from 1st March 2017

AND

Whereas, the Universities Grants Commission, New Delhi vide letter No. D.O. No. F-1-2/2008 (XI Plan) dated 31st January 2008 regarding new initiatives under the XIth Plan-Academic Reforms in the University has suggested for improving quality of higher education and to initiate the Academic Reforms at the earliest.

AND

Whereas, Direction No. 32 of 2017, in the erstwhile faculty of Social Science, governing both the Master of Library and Information Science and the Bachelor of Library and Information Science programmes, was issued by the University.

AND

Whereas, the Board of Studies, for the Library and Information Science Subjects, in the erstwhile faculty of Interdisciplinary Studies, in its meeting held during 04th October 2019 and 17th December 2019 prepared the syllabi, scheme of examination and draft Direction for THE DEGREE OF BACHELOR OF LIBRARY AND INFORMATION SCIENCE, (CHOICE BASED CREDIT SYSTEM) (SEMESTER PATTERN), AND THE POST GRADUATE DEGREE OF MASTER OF LIBRARY AND INFORMATION SCIENCE, (CHOICE BASED CREDIT SYSTEM) (SEMESTER PATTERN) and recommended to the Hon'ble Vice-Chancellor for starting the said courses from the academic session 2023-24.




AND

Whereas, Direction No. 32 of 2017 entitled "EXAMINATIONS LEADING TO THE AWARD OF POST GRADUATE DEGREE OF MASTER OF LIBRARY AND INFORMATION SCIENCE, (CHOICE BASED CREDIT SYSTEM) (SEMESTER PATTERN)", could not be converted into an Ordinance and has lapsed by virtue of the provisions of the provision to section 12(8) of the Act necessitating issuance of a fresh Direction incorporating the provisions of the said (lapsed) Direction;

Now, therefore, I, **Dr. Subhash R. Chaudhari**, Vice-Chancellor of Rashtrasant Tukadoji Maharaj Nagpur University, in exercise of my powers under section 12(8) of The Maharashtra Public Universities Act, 2016 do hereby issue the following Direction: -

1. This Direction may be called "ADMISSION AND EXAMINATIONS LEADING TO THE DEGREE OF BACHELOR OF LIBRARY AND INFORMATION SCIENCE, (CHOICE BASED CREDIT SYSTEM) (SEMESTER PATTERN) AND THE AWARD OF POST GRADUATE DEGREE OF MASTER OF LIBRARY AND INFORMATION SCIENCE, (CHOICE BASED CREDIT SYSTEM) (SEMESTER PATTERN), DIRECTION 2023"
2. This Direction shall come into force from the date of its issuance and shall also govern admission of students and their examinations in the Master of Library and Information Science programme from the academic session 2023-2024 and onward.
3. **Definitions:** - In this Direction, unless the context otherwise requires: -
 - a. "Academic Council" means Academic Council of Rashtrasant Tukadoji Maharaj Nagpur University.
 - b. "ATKT" means "Allowed to Keep Term" in the higher semester, as per the rules herein.
 - c. "Board of Studies" means Board of Studies for the subject of Library and Information Science.
 - d. "Credit Points" refer to the product of No. of credits multiplied by the Grade Point for a given course/paper.
 - e. "Credit" means the unit by which the course work is measured. In this Direction one credit means 1 hour of teaching work or Two hours of practical work per week for 12 weeks in a Semester.
 - f. "Cumulative Grade Point Average (CGPA)" refers to the cumulative Grade Point Average weighted across all semesters of the course i.e. Semester I to IV.





- g. "Fees" means the fees prescribed by the University from time to time.
- h. "Grade Letter" is an index to indicate the performance of a student in a particular course (Paper). It is the transformation of actual marks secured by a student in a course/paper. Grade letter are O, A, B, C, D, E, F, AB.
- i. "Grade Point" is the weightage allotted to each grade letter depending on the range of marks awarded in course/paper.
- j. "Programme" means Bachelor of Library and Information Science / Master of Library and Information Science.
- k. "Semester Grade Point Average (SGPA)" refers to the performance of a student in a given semester. SGPA is based on the total credit points earned by a student in all the courses and the total number of credits assigned to the course/papers in a semester.
- l. "Student" means student admitted to Post Graduate programme in Library and Information Science under this direction.
- m. "University" means Rashtrasant Tukadoji Maharaj Nagpur University.

4. **Admission: -**

- a. An applicant for the Bachelor of Library and Information Science / Master of Library and Information Science programming must be any graduate of Rashtrasant Tukadoji Maharaj Nagpur University or any other University recognize to be equivalent to the degree of the University.
- b. An applicant having the degree of Bachelor of Library and Information Science of the University or any other University which is recognize to be equivalent degree by the University shall be eligible to get admission in the second year of Master's programme (Third Semester) under this direction.
- c. Bachelor of Library and Information Science Semester-I and Semester-II will be treated as equivalent to Master of Library and Information Science Semester-I and Semester-II.
- d. Subject to the reservation policy of the State Government issued from time to time and adopted by the University the admissions of the students in the programme shall be on the basis of comparative merit.

- 5. **Duration of Course: -** Duration of Bachelor of Library and Information Science programming shall be of one year comprising two semesters. Duration of Master of Library and Information Science programming shall be of two years comprising four semesters.
- 6. **Medium of Instructions: -** The medium of instructions shall be English/Marathi/Hindi language.
- 7. **Course Structure: -** The detail semester wise course structure shall be given in Appendix-I to this direction.








As per NEP-2020 guidelines, the students have given provisions to opt for SWAYAM / MOOCS courses. Due provisions are made in the scheme of the programme as an Elective. These courses are option for MLISc programme.

Those who are opting for SWAYAM / MOOCS courses has to follow following criterias:

Note: The affiliated Colleges/ Department shall declare the Elective/Specialization it is offering before the commencement of admission process of Semester -I in their Information Brochure and website and communicate the same to the University well in advance. The Colleges/ Department will offer the Specialization only if minimum TEN students opt for the same.

a. MOOCs: - Every student admitted to this program successfully complete TWO Massive Online Open Courses available on portal to become eligible for the award of MLISc degree. The credit points of MOOCs earned by a student shall be transferred in the Mark list of Semester IV. The student has liberty to complete these two courses any time during the MLISc program after his/her admission and it is not restricted to any specific semester/s. However, the student is advised to successfully complete these MOOCs before 4th Semester.

b. In compliance with the Choice Based Credit System, the student is free to opt for any course available on the SWAYAM/NPTEL portal during a particular semester provided the course has minimum 4 credits. Following guidelines are to be followed by the concerned stakeholders such as students, University and College/ Department to enable student to opt for MOOC and the credit transfer of such MOOC completed by the student.

i. The College/Department shall provide the list of courses (with minimum 4 Credits/minimum duration of 12 weeks) available in the beginning of each semester to students on its website, college notice boards and through other medium of communication. Similarly, such a list shall also be published on the University's/ Colleges website.

ii. A student may select the course (with minimum 4 Credits/minimum duration of 12 weeks) of her/his choice from the available courses and register for the same.

iii. A student is also required to appear and successfully complete the online examination for the MOOC opted by him/her.

iv. The successful completion of TWO such MOOCs comprising of total 8 Credit Points is mandatory for every student to become eligible for the award of degree.

v. If a student has completed a MOOC carrying more than 4 credits, then only 4 credits shall be considered and be shown in the mark list of 4th Semester against such course.

- vi. In case, the MOOC certificate does not have a mention of Credits, the Principal/Head shall certify the number of credits for which a course of minimum duration of 12 weeks shall be considered equivalent to 4 credits.
- vii. A student is expected to fill the examination form for Semester IV along with the titles of courses (MOOC courses) he/she had completed or pursuing.
- viii. The University shall provide an option as „MOOC-1“ and „MOOC- 2“ in the drop-down list while filling up the online examination form for IVth Semester.
- ix. The marks/grade obtained by the student in such MOOCs shall be submitted by the College/Department (with copy of Certificate) to the University along with Internal Assessment Marks for Semester IV.
- x. In case a student is not able to complete TWO MOOCs by the end of Semester IV, he/she shall be marked absent in MOOC – 1 and MOOC – 2 subjects in the Semester IV Mark list. Such students, on successful completion of MOOCs and submission of certificates to that effect, shall be declared successful and become eligible for award of degree.
- xi. The Board of Studies in Library and Information Science shall appoint a „Steering Committee“ to deal with the difficulties and problems of students/Institutes arising out of this scheme.
- xii. The online examination of such courses (MOOC) is conducted by Host Institutions and not by the University and the dates of examination are declared at the beginning of the session. Hence, the University shall keep these days free from its MLISc Examination Time-Table and shall not schedule any End Semester Examination on such dates.
- xiii. The examination fee of MOOCs is to be paid and borne by the student separately.
8. **Attendance:** - In order to be eligible for appearing in the University examination, the student must have attended minimum 75% of the classes engaged, certified by the Principal of the college/head of the institution or the department.
9. **End Semester Examination:** - There shall be University examination at the end of each semester.
10. **Standard of Evaluation:** -
- a. The maximum marks in each subject, both the theory as well as practical, will be 100, which shall be divided into two heads namely i) “external” and ii) “internal” carrying 80 marks and 20 marks respectively. However, the project work in the fourth semester shall carry 200 marks with 50% passing marks.

- b. The University examination, for 80 marks theory and practical paper, would be of three hours duration. The Internal Examiner for theory and practical shall be the approved Post Graduate teacher, who is teaching the subject for last Three years or more than.
 - c. The minimum passing marks in each theory and practical component of the programme shall be 50%.
 - d. The minimum passing marks in each subject/paper shall be the combine of the University examination and internal assessment. In other words, there shall not be separate minimum passing marks for theory (external) examination and internal assessment head of the subject/paper, provided that the student must appear for the internal assessment in the subject/paper.
11. For Project work a batch of Maximum FIVE students per guide/supervisor has to be allotted by the College/Department. The Guide/Supervisor shall act as an internal examiner for project Examination.
- (i) The guide or the supervisor shall be appointed by the college/department and should be teaching in the MLISc Programme with minimum qualifications as prescribed by UGC for Assistant Professor.
 - (ii) The External examiner for Project Evaluation and Seminar shall be appointed from the list of full-time approved teaching faculty of the MLISc programme by the University.
 - (iii) ONE copy of Project work (Printed and hard bound) shall be submitted to the College/Department at least one month before commencement of MLISc Semester IV Examination for evaluation purpose. The college/Department shall retain the copy of Project Work for evaluation.
- A Candidate shall submit with his/her project work, a certificate from the Supervisor to the effect: -
- That the candidate has satisfactorily completed the Project work for not less than one session;
 - That the Project work is the result of the candidate's own work and is of sufficiently high standard to warrant its presentation for examination.
 - Candidate shall submit his declaration that the Project is the result of his own research work and the same has not been previously submitted for any examination of this University or any other University. The Project shall be liable to be rejected and /or cancelled if found otherwise.
 - The Exit Seminar Presentation and Open Defense shall be evaluated through Seminar, Presentation and Open Defense at the college/department by external examiners appointed by the University.
 - A student appearing for the Semester IV Examination will have to pay additional fees as prescribed by the University from time to time.
 - A student can complete his/her project work in any language i.e. English/ Marathi/Hindi.

12. **Benefit of exemption in a subject/paper:** - Where a student fails in University examination, the student shall be entitled to get exemption in the theory or practical component of the programme if he/she secures minimum passing marks.

13. **Credit and Grade Point System:**

- A. **Conversion of Marks to Grades and Calculations of SGPA (Grade Point Average) and CGPA (Cumulative Grade Point Average):** In the Credit and Grade Point System, the assessment of individual Courses in the concerned examinations will be on the basis of marks only, but the marks shall later be converted into Grades by some mechanism wherein the overall performance of the Learners can be reflected after considering the Credit Points for any give course. However, the overall evaluation shall be designated in terms of Grade. There are some abbreviations used here that need understanding of each and every parameter involved in grade computation and the evaluation mechanism. The abbreviations and formulae used are as follows: -

G: Grade

GP: Grade Points

C: Credits

CP: Credit Points

CG: Credits X Grades (Product of credits & Grades)

SGPA = $\sum CG$: Sum of Product of Credits & Grades point / $\sum C$: Sum of Credits points

SGPA: Semester Grade Point Average shall be calculated for individual semesters. (It is also designated as GPA)

CGPA: Cumulative Grade Point Average shall be calculated for the entire Programme by considering all the semester taken together.

CGPA to Percentage (%) Conversion formula: Percentage (%) = (CGPA) * 10

After calculating the SGPA for an individual semester and the CGPA for entire program, the value can be matched with the grade in the Grade Point table as per the ten (10) Point Grading System and expressed as a single designated GRADE such as O, A, B, C, D, P and F

A student obtaining Grade F shall be considered failed and will be required to reappear in the examination.

- B. Division at the Master of Library and Information Science (MLISc) examination shall be declared on the basis of the aggregate marks at the MLISc semester I, semester II, semester III and semester IV examination taken together and the CGPA will be calculated and notified.
- C. **The successful examinees at the MLISc semester IV examination shall be awarded division based on CGPA**
- D. The percentage of passing marks in each subject shall be as indicated in Examination Scheme (Item no 12) "A, "B, "C, "D, "E and "F" respectively.
- E. Unsuccessful examination at the above examination can be readmitted to the same examination on payment of a fresh fee and such other fees as may be prescribed.
- F. **Provisions of Ordinance No. 3 of 2007** relating to the award of Grace Marks for passing an examination, securing higher division/ class and securing distinction in subject(s) shall applicable.
- G. University guidelines & direction updated from time to time regarding Improvement of results, Revaluation/ Reassessment and Incentive Marks shall be applicable to MLISc program governed by this direction.
- H. Notwithstanding anything to the contrary in this Direction, no person shall be admitted to an examination under this Ordinance, if he/ she has already passed the same examination or an equivalent examination of any other University.
- I. Examinees passing all the **Master of Library and Information Science (MLISc)** Examination shall on payment of the prescribed fees shall receive a Degree in the prescribed form signed by the Vice-Chancellor.
- J. The aforesaid Amendment shall come into force from the date of its issuance and shall remain in force till the relevant Ordinance comes into being in accordance with the provisions of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017).
- K. The marks for internal assessment should be communicated to the University within the time limit as per university norms. The record of conduct of such examination, evaluation and marks for internal assessment should be maintained for a period of at least one year by the respective college / Department for the verification by the competent authority.

14. Promotion to Higher Semester (ATKT):- With reference to the Direction issued by the University time to time regarding ATKT will be applicable.

1 st Semester	Candidate should have passed the qualifying examination as per the relevant Direction governing the course.
2 nd Semester	Candidate should have completed the term of the 1 st Semester and filled examination form.
3 rd Semester	Candidate should have completed the term of the 2 nd semester, filled the examination form of the same and has obtained exemption in 2/3 rd passing heads of the 1 st and 2 nd semesters taken together
4 th Semester	Candidate should have completed the term of the 3 rd semester and filled the examination form of the same.

15. Prizes, Awards and Medals: An examinee passing an examination having availed the facility of exemption or passing the examination with grace mark shall not be eligible for any prize, award or medal; nor shall he/she be entitled for the place in the merit list.
16. Saving: - Notwithstanding lapse of Direction No. 32 of 2017 all actions taken in pursuance of the said Direction shall be valid and binding on all the concerned persons.
