PROCEDURE TO PROVIDE FORNOMINATION OF THE REPRESENTATIVES OF THE EDUCATION COMMITTEES OF ZILLA PARISHADS ON THE SENATE, DIRECTION, 2022

Whereas, the Maharashtra Public Universities Act, 2016 (Maharashtra Act No. VI of 2017) (hereinafter the "Act") has come into force w.e.f. 1st March 2017, repealing the Maharashtra Universities Act, 1994;

AND

Whereas, the Act VI of 2017 has been made applicable to the Rashtrasant Tukadoji Maharaj Nagpur University Nagpur with effect from 1st March 2017;

AND

Whereas, section 28 of the Act dealing with the composition of the Senate of the University provides for nomination of one representative of the Education Committee of Zilla Parishads within the University area, by the Education Committee for the term of one year, by rotation;

AND

Whereas, the Statute No. 32 of 2010 dealing with the nomination of representative of Education Committee of Zilla Parishad has become inconsistent with the provisions of section 28(2)(z) of the Act and is therefore deemed to have been repealed;

AND

Whereas, it is desirable to frame a Statute to lay down the procedure for determination of rotation of nomination of representatives of Education Committees of the Zilla Parishads on the Senate of the University;

AND

Whereas, making of the Statute is a time consuming process therefore Direction no. 3 of 2018 was issued on 15.2.2018 but the same could not be converted into a statute within six months of its issuance and therefore is lapsed on the expiry of said period.

AND

Whereas, the term of elected members of the Senate is over in 2022 and the process of election for constitution of new Senate is going onand the nominations to the authorities of the University is required to be completed by 30thof November and as such there is an exigency to issue a Direction;

Now, therefore, I, Dr. Subhash R. Chaudhari, Vice-Chancellor, Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur, in exercise of the

powers conferred upon me under section 12(8) of the Act do hereby issue the following Direction:-

- 1. This Direction may be called "PROCEDURE TO PROVIDE FORNOMINATION OF THE REPRESENTATIVES OF THE EDUCATION COMMITTEES OF ZILLA PARISHADS ON THE SENATE, DIRECTION, 2022.
- 2. This Direction shall come into force with effect from the date of its issuance.
- 3. In this Direction, unless the context otherwise requires:-
 - (a) "Representative of Education Committees of the Zilla Parishad" means a member of Education Committees of Zilla Parishads within the University area.
 - (b) "University" means Rashtrasant Tukadoji Maharaj Nagpur University.
- 4. Whereas as per the provision of section 28(2)(z) of the Act one representative of the Education Committee of Zilla Parishads, within the University area, is to be nominated on the Senate of the University by the Education Committee of the Zilla Parishads, for a term of one year, by rotation, and since as per entry 5 in Part-I of the Schedule to the Act there are four different districts within the jurisdiction of the University it is necessary to determine the point of rotation. Therefore the Vice-Chancellor shall draw the lots and determine the point of rotation. The four districts mentioned in entry 5 in Part-I of the Schedule are:
 - i. Bhandara
 - ii.Gondia
 - iii.Nagpur
 - iv.Wardha.
- 5. The Registrar of the University shall write to the Chief Executive Officer of the ZillaParishad, whose representative is to be nominated by its Education Committee, requesting him/her to send the nomination on the Senate of the University for a period of one year.
- 6. At least one month before the expiry of the term of the representative of the ZillaParishad on the Senate the Registrar shall send the letter of request to the CEO of the concerned ZillaParishadof the Districts in the order in which the rotation has been determined under para 4 above.
- 7. If in future any new District is included within the jurisdiction of the University, in terms of the provisions of the Maharashtra Public Universities Act, 2016 or any other law, the same shall be inserted as entry no. V and so on under para number 4 herein.
