NORMS AND PROCEDURE FOR GRANT OF RE-AFFILIATION TO THE COLLEGES/INSTITUTIONS, DE-AFFILIATED BY THE UNIVERSITY, DIRECTION - 2024.

WHEREAS, the Maharashtra Public Universities Act, 2016 (Maharashtra Act No. VI of 2016) (hereinafter referred to as the Act) has come into force with effect from 1st March 2017 and the same has been made applicable to Rashtrasant Tukadoji Maharaj Nagpur University (hereinafter the University);

AND

WHEREAS, as per the provisions of Clause (m) of Sub-Section (1) of Section 33 of the Act, the Academic Council of the University is the Competent Body to prescribe norms for granting affiliation as well as for continuation of the affiliation, etc.;

AND

WHEREAS, the Direction No. 34 of 2024 is issued by the University prescribing the norms and procedures for the grant of affiliation or continuation of affiliation of the colleges/institutions, etc.;

AND

WHEREAS, the Direction No. 16 of 2024 has been issued prescribing the norms for closure/change of site/location, change of name, change of management and merging of the colleges/institutions etc.;

AND

WHEREAS, some of the colleges /institutions of the University have been dis-affiliated for various reasons of the University and whereas there was a demand for prescribing norms and procedure for re-affiliation of dis-affiliated colleges/institutions of the University and therefore, a Committee under the Chairmanship of Hon'ble Pro-Vice-Chancellor Dr. Sanjay Dudhe was constituted by the Academic Council in its meeting held on 8th July, 2022;

AND

WHEREAS, the said Committee has submitted its report prescribing the procedure and the norms for re-affiliation of the colleges/institutions which are dis-affiliated by the University;

AND

WHEREAS, the said recommendations of the Committee under the Chairmanship of Dr. Sanjay Dudhe has been accepted on behalf of Academic Council by the Hon'ble Vice-Chancellor under Clause 7 of Section 12 of the Act and Whereas Statute making is a time consuming process and the matter is required to be regulated urgently thus there is a exigency for issuance of this Direction;

Now, therefore, I Dr. Prashant S. Bokare, Vice-Chancellor, Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur, in exercise of the powers vested in me under provision of Sub-Section 8 of Section 12 of the Maharashtra Public Universities Act, 2016 do hereby issue the following Direction:

- 1. This Direction may be called "the Norms and Procedure for grant of re-affiliation to the colleges/institutions, de-affiliated by the University Direction-2024".
- 2. This Direction was come into force w.e.f. from the date of issuance.
- 3. In this Direction unless the context otherwise requires:-
 - (a) "Act" means the Maharashtra Public Universities Act, 2016.
 - (b) "Academic Council" means the Academic Council constituted as per Section 32 of the Act.
 - (c) "Affiliated Colleges" means a college which has been once granted affiliation by the University.
 - (d) "De-affiliated Definition" means a college/institution which has been de-affiliated by the University.
- 4. The Colleges/Institutions which are not de-affiliated but due to some reason they have not applied for continuation of affiliation, wherein there is a procedure prescribed that such colleges can make an application with penalty and, therefore, as per the recommendations of the Committee such colleges/institutions will be governed by the existing procedure only.
- 5. The Colleges/Institutions de-affiliated by the University but the Management of such colleges/institutions are having intention to

re-start such de-affiliated colleges/institutions such colleges shall follow the following procedure.

- (a) The Management of such college shall make an application to the University (College Section) regarding their intention to re-start the de-affiliated colleges/institutions.
- (b) Such college is required to fulfil all the conditions required for establishment of a new college/institute as provided Govt. Resolution dated 15.09.2017.
- (c) If requirement of above stated Govt. Resolution is fulfilled the Society/Management of the college shall, after taking resolution to that effect, make an application to the University by paying the fees of Rs. 50,000/- (Rs. Fifty Thousand only).
- (d) On receipt of the said application, to visit the premises of the college, a Committee under the Chairmanship of Dean of the respective faculty should be constituted.
- (e) The Committee so constituted shall examine by visiting the spot requirement of Govt. Resolution dated 15.09.2017 are fulfilled and shall submit its report. Report shall show the measurements and area of existing facility and that is expected in Govt. Resolution dated 15.09.2017. Committee shall opine its remark, if the facility are sufficient or deficient.
- (f) If the report of the Committee is positive then from the Academic Session the college/institute was de-affiliated since then till date i.e. for the Academic Session the affiliation is likely to be granted for each Academic Session penalty of Rs. 1,00,000/- (One Lakh only) shall be imposed.
- (g) Beside the penalty of Rs. 1,00,000/- (Rs. One Lakh only) for each Academic Session the Management/Society is also required to

draw a fix deposit of Rs. 10,00, 000/- Rs. Ten Lakh only) in the

joint name of the University and the concerned society.

(h) On making the payment of above penalty if the receipt is

produced alonwith the fix deposit off Rs. 10,00,000/- (Rs. Ten

Lakh only) the affiliation to such college/institute may be

granted.

(i) Once the affiliation (re-affiliated) under this Direction is granted

to a college/institute such institute/college can not be

transferred to any other Society/Management.
