ORDER

1. The Applicant approached this Grievances Committee under Section 79 of the Maharashtra Public Universities Act, 2016 with a prayer to claim relief for his grievances regarding his claim

for promotion to the Head of the Department of Chemistry in the Non-Applicant' College. The Applicant has come forward with the contentions that he is presently working as Professor in the Department of Chemistry in the Non-Applicant' College and the Non-Applicant No. 3 is working as Associate Professor in the Department of Chemistry and she holds the charge of Head of the Chemistry Department from 1st January, 2023 after retirement of Dr. Mrs. Ratna Sarkar on 31.12.2022.

2. It is submitted by the Applicant that he was appointed as an Assistant Professor on 23.09.2013 in the Non-Applicant College in the Department of Chemistry and he was promoted to the post of Professor under CAS. His promotion is also approved by the Rashtrasant Tukadoji Maharaj Nagpur University by order dated 22.08.2022 and approval was granted to his promotion from 17.01.2022. The Applicant has also filed the copy of the letter of approval dated 22.08.2022 issued by the Rashtrasant Tukadoji Maharaj Nagpur University which is filed as Annexure-A. It is further submitted by the Applicant that the Non-Applicant No. 3 is on the post of Associate Professor and she is yet become eligible to be promoted on the post of Professor under CAS. And it is further submitted that the Non-Applicant No. 1 & 2 are erroneously considering the Non-Applicant No. 3 as Senior to the Applicant and they have given charge to Non-Applicant No. 3 as Head of the Chemistry Department.

3. The Applicant had also sent a representation as per his claim letter dated 29.12.2022 to the Non-Applicant No. 1 & 2 but no reply was given, the copy of letter is filed as Annexure-C. Thereafter again the Applicant has given representation on 19.01.2023, the copy of it is filed as Annexure-D and the Applicant was informed that his claim will be reconsidered if he submits any Govt. Resolution in respect of the appointment of Head of the Department and as per letter dated 07.02.2022, the Applicant's claim was rejected, the copy of letter issued by the Non-Applicant No. 1 is filed as Annexure-E. Thereafter the Applicant again made a representation dated 15.02.2023, the copy of it is filed as Annexure-F with the copy of Govt. Resolution dated 30th July 2010, copy of it is filed as Annexure-G.

4. The Applicant has also filed the copy of Govt. Resolution dated 8th March, 2019 with the Annexure-J, the copy of Direction No. 20 of 2019 issued by the Rashtrasant Tukadoji Maharaj Nagpur University which is filed as Annexure-M and the copy of Notification dated 18th July, 2018 issued by the University Grants Commission (UGC) is filed as Annexure-Q. And it is prayed by the Applicant to declare that he is senior than the Non-Applicant No. 3 and further to direct the Non-Applicants to handover the charge of Head of the Chemistry Department in the Non-Applicant's College.

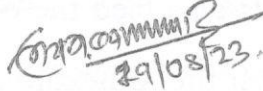
5. Notices were issued to the Non-Applicants and during the proceeding, the Applicant and Registrar of the Non-Applicant's
