ORDER

(Delivered on 03-07-2021)

The Applicant is appointed as Assistant Professor in a college run by Non-Applicant No. 1 to work under the Principal Non-Applicant No.2, w.e.f. 23.3.2021 on full time basis. He has cleared NET. He was due for first placement in the year 2014. His request was not considered by the Principal, it is alleged.

- 2. In this grievance petition under Section 87(1) of the Maharashtra Public Universities Act, 2016, the Applicant has sought the following reliefs viz:
 - (1) Illegal deduction from the salary of December-2019.
 - (2) Avoiding due placement procedure.
 - (3) Avoiding acknowledgement of letters.
 - (4) Damaging the attendance register.
- 3. In support of the prayer, the applicant has filed the following documents:
 - (1) Salary Certificate.
 - (2) Photocopy of Pass Book.
 - (3) Letters addressed to the Principal.
 - (4) Letter to the Joint Director High Education, Nagpur.
- 4. Notice was issued to the Non-Applicants. However, instead of filing reply, by a letter dated 29.1.2021 the Principal informed that the Applicant's claim has been amicably settled on the college level and hence the Grievance Petition became redundant. By a separate letter dated 29.01.2021, the Applicant has also informed this Grievances Committee that his grievance has been satisfied at Principal level.
- 5. Thereafter, the matter could not be taken up on account of lock down due to Corona Pandemic from Pennuary-2021. The same was taken up today for consideration and hearing. However, nobody appeared inspite of notice.

- 6. On perusal of record the Grievances Committee is satisfied that the claim has been amicably settled between parties and Applicant is satisfied with it. Hence, grievance does not survive.
