ORDER

(Delivered on 12/04/2022)

1. The Applicant approached this forum under Section 79(1)
 of the Maharashtra Public Universities Act, 2016 seeking following
 relief as per the prayer clause:

(a) Direct the Non-Applicants to fix the pay of the Applicant in the
 appropriate pay scale and pay the Applicant arrears arising
 out of such fixation;

- (b) Direct the Non-Applicants to pay the regular monthly salary as per the pay scales applicable to the post of Attendant as prescribed by the University and the UGC as well as the 7th Pay Commission;
- (c) Direct the Non-Applicants to fix the salary of the Applicant as per the recommendations of the Pay Commission and release the increments and further release the arrears accordingly;
- (d) Cost of Rs. 25,000/- be saddled upon the Non-Applicants for the torture and humiliation they have given to the Applicant and further for the mental pressure and physical pain the Applicant has gone through;
- (e) Grant any other or further relief including costs as may be deemed fit in the facts and circumstances of the case and also in the interest of justice.

2. The Applicant came to be appointed as Attendant in the Respondent No. 3 college vide order dated 01.04.1995. It is the grievance that although having a clean service record, he was not paid salary as per the Pay Commission and UGC scale. Hence, this petition.

3. On notice, the Respondent appeared and before filing reply the matter was settled between the parties and it is stated by the Applicant on interrogation who is present today before the Committee along with Shri Chetan Wazalwar, the Administrative Officer of the college, under instructions from the Respondents stated that he does not want to proceed with the matter, since the claim is satisfied and he therefore, desires to withdraw the Grievance Petition. The Respondents have no objection for withdrawal.

4. On interrogation with the parties, we are satisfied that withdrawal is voluntary and beneficial in the interest of both the parties, since the Applicant stated that the cheque of the amount settled has been credited to his bank account. It is stated that the Applicant already retired on 28.10.2021.
5. In view of above nothing survives in this Grievance Petition. The Grievance Petition, therefore, stands disposed of as withdrawn un-conditionally.
6. The parties are directed to bear their respective costs of this proceeding.
7. The office is directed to forward authenticate copy of this order to both the parties at the earliest.
8. Withdrawal pursis shall form part of this order.

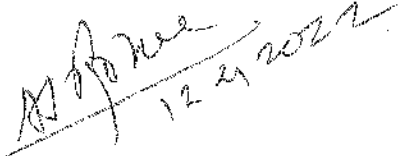

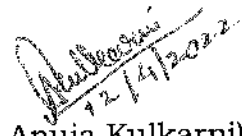

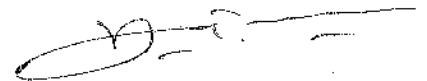
