REPORT

The Post Graduate Teaching Department of Law, Rashtrasant Tukadoji Maharaj Nagpur University Organised a "One Day Skill Development Workshop" Dated 11th February, 2023 (Saturday) held from 9.30 a.m. to 1 p.m. There were three sessions in the said workshop. The noteworthy resource person of the Session-I was Dr. Madhavi Mardikar, Head, Department of Physical Education, RTMNU, enlightened us on the topic of Stress Management. The keynote speaker of the Session-II was Mr. Rahul Bhosale, Special Judge, CBI Court, Nagpur, emphasized on Knowing Our Court System. The Session-III was proceeded with the illustrious resource person Dr. Aanchal Mundafale, Assistant Professor, MAM College of Social Work, Narkhed, thrown light upon the Language Skills.

Dr. Payal Thaorey, Head of the Department, PGTD of Law,RTMNU, Nagpur welcomed all the dignitaries at the dice and the participants also. She explained the objectives behind the workshop and uttered that this workshop will be benefitted with the epitome knowledge and technical know-how of the resource persons to all the participants. The comparers of this worshop Mr. Kushal Jain and Ms. Madhura highlighted the workshop's mechanism and schedule and they also informed about the Question and Answer sessions in which the participants can ask their queries to the resource persons directly.

The first session begin with welcoming of Dr. Madhavi Mardikar ma'am by our Mrs. Dipali Mankar ma'am. The eminent speaker Dr. Madhavi Mardikar emphasized upon the management of the stress specifically in the life of the lawyers. The noteworthy resource person of the Session-II Mr. Rahul Bhosale was welcomed by our Dr. Payal Thaorey ma'am. The Speaker threw light upon the working of the Court and the

procedure to be followed in the Court of law while disposing any case. He carved out the stages involved in civil suit as-


Presentation of plaint., 2. Service of summons on defendant., 3. Appearance of parties, 4. Ex-parte Decree, 5. Interlocutory Proceedings, 6. Filing of written statement by defendant, 7. Production of documents by parties (plaintiff and defendant), 8. Examination of parties, 9. Discovery and Inspection, 10. Admission, 11. Framing of issues by the court., 12. Summoning And Attendance Of Witnesses, 13. Hearing Of Suits And Examination Of Witnesses, 14. Argument, 15. Judgment, 16. Preparation of Decree, 17. Appeal, Review, Revision, 18. Execution of Decree.


He also explained what is cognizable and non congnizable offence, summons case and warrants case, what is the difference between complaint and FIR and also stated the hierarchy of Civil Courts and Criminal Courts of law in India.


