B. Empanelment :- Eligibility Criteria:-

- All Panel Advocates shall submit the monthly status of the Cases allotted to them to Registrar, R.T.M.N.U.
- ii. Cases shall be allotted to all the panel Advocates by rotation in consultation with the Standing Counsel and a record to that effect shall be maintained by the Law Officer of University which shall be placed before the Committee constituted by the Management Council after every three months. However Hon'ble Vice-Chancellor in consultation with the Committee can allot the matter to the Specific Advocate in the interest of the University.
- iii. It is the discretionary powers of the R.T.M.N.U. to remove an Advocate from the panel if such Advocate is found guilty of any misconduct or engaged in the activities which are detrimental or against the interest of R.T.M.N.U.
- iv. Empanelled Advocate should not appear (directly or indirectly) in the matter against the R.T.M.N.U. and if found so, such Advocate shall be removed from the panel with immediate effect.

C. Cases in Courts outside Nagpur :-

So far as the cases in the Courts outside Nagpur are concerned, the Legal Section in consultation with the standing counsel, the Hon'ble Vice-Chancellor and or the Registrar can appoint an advocates of that city/state.

Enhancement of Legal Fees of Panel counsels of University: D.

The present fees are comparatively enough than the fees paid by other Univesities. The fees shown in the circular of dt. 8th August, 2013 are kept as it is, which is as under:

SUPREME COURT PANEL COUNSEL: - The fees payable to the Panel Counsel of Supreme Court shall be ascertain and be fixed to avoid any complication and difficulty in administration.

After discussion, it has been decided that the fees payable to the Panel Counsel of Supreme Court will be Rs. 20,000/- (Twenty thousand) per case and the amount of Rs. 3000/- will be admissible for the purposes of expenditure. However, the fees of the Senior Counsel of Supreme Court will be decided by the Hon'ble Vice Chancellor considering the importance of case.

- 2. HIGH COURT PANEL-'A' COUNSEL: The fees payable to counsel in Panel 'A' for High Court, will be Rs. 10,000/- and amount of Rs. 2000/- will be admissible on account of expenditure.
- 3. LEGAL FEES OF PANEL 'B' COUNSEL: The fees payable to Panel 'B' Counsel of High Court will be Rs. 7,000/- & amount of Rs. 2,000/- on account of expenditure (per case) will be admissible.
- 4. M. A. T. PANEL COUNSEL: The fees payable to the Panel Counsel for Maharashtra Administrative Tribunal will be Rs. 10,000/- plus Rs. 2,000/- an account of expenditure.
- **5. UNIVERSITY AND COLLEGE TRIBUNAL PANEL COUNSEL:** The fees payable to the Panel Counsel for University and College Tribunal will be Rs. 8,000/- plus Rs. 1,500/- on account of expenditure. All other condition will be applicable as it is.
- **6. DISTRICT COURT PANEL COUNSEL:** The fees payable to the Panel Counsel for District Court will be Rs. 10,000/- plus Rs. 2,000/- on account of expenditure.
- 7. CRIMINAL COURT PANEL COUNSEL: The fees payable to the Panel Counsel for Criminal Court will be Rs. 8,000/- plus Rs. 1,000/- on account of expenditure.
- 8. CONSUMER COURT PANEL COUNSEL: The fees payable to the Panel Counsel for Consumer Court will be Rs. 8,000/- plus Rs. 1,000/- on account of expenditure.
- 9. INDUSTRIAL AND LABOUR COURT PANEL COUNSEL: The fees payable to the Panel Counsel for Industrial and Labour Court will be Rs. 8,000/-plus Rs. 1,000/- on account of expenditure. All other condition will be applicable as it is.
- **10. REVENUE COURT PANEL COUNSEL:** The fees payable to the Panel Counsel for Revenue Court will be Rs. 8,000/- plus Rs. 1,000/- on account of expenditure.

- 11. <u>DRAFTING OF DEEDS AND AGREEMENTS:</u> The fees payable to the Panel Counsel for Drafting of Deeds and Agreements will be Rs. 2,000/- and amount on account of expenditure will be separately admissible.
- 12. <u>LEGAL OPINION:</u> The fees payable to the Panel Counsel for Legal Opinion will be Rs. 300/- per opinion.
- 13. LEGAL NOTICE OR REPLY NOTICE: The fees payable to the Panel Counsel for Legal Notice or Reply Notice will be Rs. 1,500/- and amount on account of expenditure will be separately admissible.
- **Note 1:-** It is made clear that if there is no necessity of reply or no reply is filed by the Counsel, amount on account of expenditure will not be admissible.
- Note 2:- The limits of expenditure prescribed above will depend upon the bulk of documents and charges on account of steno, typing, translation and Xerox etc. and in that case with the permission of Registrar the limit would be suitably increase.
- Note 3:- 50% fees would be payable at initial stage and 50% after final disposal of case.
- **Note 4:** In the matters where the University or the authority of University etc is 'formal party' and if there are identical matters more than one the fees payable to the Panel Counsel would be 50%.
- **Note 5**:- The fees payable to the senior counsel to be engaged in Supreme Court, High Court or in Any other Court would be decided by Hon'ble Vice Chancellor.
- **Note 6:** At the time of submitting final bill the copy of judgment has to be enclosed by the counsel.
- **Note 7**:- The expenditure required for obtaining Certified Copies will be admissible separately.
- **Note 8**:- The new rates of fees will be applicable w.e.f. 19.03.2013 i.e. from date of decision of Management Council.

(Note No. 1 to 8 would be applicable to the Panel Counsels of all Courts.)

HONORARIUM OF STANDING COUNCIL: -

As recommended by the Committee Honorarium payable to the Standing Council will be Rs. 25,000/- (Twenty-Five Thousand) per month.

E. Engagement of Senior Counsel: -

As per the importance of issue and stake involved in the matter, the Hon'ble Vice-Chancellor and the Registrar can engage senior counsel consulting the Standing Counsel. The Fee Structure of Senior Counsel will be decided by Hon'ble Vice-Chancellor and Registrar before engaging the Senior Counsel.

The Standing Counsel of the University will be overall in-charge of all Court cases and will have to co-ordinate the work of panel Advocates in all the courts and Tribunals. The court cases can be allotted by the Hon'ble Vice-Chancellor and Registrar in consultation with Standing Counsel.

The Standing Counsel can adopt the necessary measures for effective conduct of cases in all the Courts and Tribunals and he can appear in any case in any court or tribunal. Considering the responsibilities of the Standing Counsel it is recommended that the existing Honorarium/retainer ship payable to the Standing Counsel to be increased up to Rs. 25,000/- per month.
