### **SECTION-1**

1.01(a)(i): To receive the modified minutes of the meeting of the University Grants

Commission with the Hon'ble Human Resource Development Minister,

Shri Arjun Singh, held on 14<sup>th</sup> November, 2006.

  The Commission examined the issue of grant of Deemed to be
  University status and resolved that institutions accredited by
  NAAC with at least 'B' Grade or NBA accredited institutions
  may only be considered for Deemed to be University status. This

will, however, not apply to the cases where Expert Committee have already visited the institutions or where there is no accreditation mechanism available such as Medical, Dental, Nursing, Physiotherapy etc., where the approval of respective council will be adequate.

Engineering College, Chennai and Thai Moogamgigai Dental College and Hospital, Chennai and agreed for its continuation and the review of Dental College after a period of two years.

Its further continuation would be decided after review of the institute in the third year..
