#### **SECTION-1**

**1.01 (a)** To confirm the minutes of the 453<sup>rd</sup> meeting of the University Grants Commission held on 6<sup>th</sup> November, 2008.

There was detailed discussion on the "UGC (Institutions Deemed to be Universities) Regulation, 2009" (which was approved by the Commission on 6<sup>th</sup> November, 2008) in the light of the comments from the Members and the MHRD. Based on the discussion, the above Regulation was modified and approved as per APPENDIX-I. This may be sent to MHRD for concurrence and notification.

Prof. J A K Tareen, Member mentioned about the case of Shri Govindaiah Godavarthi, Lecturer in English, Maulana Azad National Urdu University, Hyderabad wherein the approval for exemption was given for UG courses. The same may be read for PG courses.

Shahu Institute of Education & Research, Kolhapur, Maharashtra, subject to a review after five years.

To consider the UGC draft Regulations for Admission and Fee Structure in Professional Programmes of study in self Financing deemed to be universities.

The Commission discussed in detail and decided to constitute a Sub-Committee of the Commission consisting of Prof. Jalees Ahmed Khan Tareen, Prof. Xavier Alphonse, S.J., Prof. Achyutananda Samanta, Dr.(Mrs.) Shashi Rai with one or two Experts and Dr.(Ms) N.A. Kazmi, AS, UGC as Member Secretary to work out a revised Regulation in the light of the discussion and a revised Regulation may be brought before the Commission at its next meeting.

The Commission considered the Expert Committee Report constituted by the Chairman, UGC to assess the proposal of National Insurance Academy, Pune, Maharashtra, report of the AICTE Expert Committee, AICTE advice and compliance submitted by the Institute and agreed to recommend to the Ministry of Human Resource Development for conferment of Deemed to be University status under Section 3 of the UGC Act, 1956 to National Insurance Academy, Pune, Maharashtra, subject to the condition that this being private Institute may not be allowed to use the word 'National' and be reviewed after five years.

To consider the matter to permit the Delhi Colleges to start new courses during 2007-08.

The Commission considered the above issue and approved that the Delhi Colleges may be allowed to start aided new courses from the current academic year.

To consider issue regarding UGC financial support to Law Universities during XI Plan Period.

The Commission considered the issue of UGC financial support to Law Universities during the XI Plan Period and noted that these Universities were established by the Acts of respective State Legislatures, which are public institutions in character to serve public cause. The Commission, therefore, decided that the developmental grants to these Law Universities may be released subject to the condition that they follow (i) UGC norms for selection and appointment of teachers including reservation policy of their respective State Governments (ii) audit of their accounts by appropriate Government agencies and (iii) the fee structure applicable to other Public Institutions.

All the Universities may be asked to submit information on above points for the last three years to enable the Commission to take final decision. If need be, the Chairman may get the same examined by an Expert Committee to be appointed by him.

The Commission considered the Expert Committee Report constituted by the Chairman, UGC to assess the proposal of Akruti Citygold Institute, Mumbai, Maharashtra, report of the AICTE Expert Committee, AICTE advice, compliance submitted by the Institute and the presentation made by it before the Commission on 19<sup>th</sup> June 2008 and decided not to recommend to the Ministry of Human Resource Development for conferment of Deemed to be University status under Section 3 of the UGC Act, 1956 to Akruti Citygold Institute, Mumbai, Maharashtra.

The Commission considered the Expert Committee Report constituted by the Chairman, UGC to assess the proposal of Balaji Vidyapeeth, Deemed to be University, Puducherry, to start off-campus centre "Shri Sathya Sai Medical College and Research Institute" at Ammapetai, Nellikupam Village, Tiriopurur-Guduvancherry Main Road, Chengalpetu Taluk, Kanchipuram District, Tamil Nadu and agreed to recommend to the Ministry of Human Resource Development to start off-campus centre "Shri Sathya Sai Medical College and Research Institute" at Ammapetai, Nellikupam Village, Tiriopurur-Guduvancherry Main Road, Chengalpetu Taluk, Kanchipuram District, Tamil Nadu from the current academic year subject to annual review for three years and subsequently after five years.

The Commission considered the Revision of scale of pay for the posts of Assistant Registrar / Assistant Controller of Examination / Assistant Finance Officer, Deputy Registrar / Deputy Controller of Examination / Deputy Finance Officer, Registrar / Controller of Examination / Finance Officer and decided that parity in the pay scales of teachers and these academic administrative posts may be considered for continuation in this revision and also the recommendations may be sent to MHRD with a request to maintain parity in the scale of pay with the teachers, as was done earlier.

To consider Comprehensive Agenda Item on Autonomous Colleges taking into account the various items and decisions that were taken by the Commission on earlier occasions.

The Commission appreciated the comprehensive agenda item on Autonomous Colleges and had a great deal of discussion. Arising out of the discussion, the Commission finally decided that the following actions may be taken:

- (1) The Chairman, UGC may write a comprehensive letter to all the Vice-Chancellors and Education Secretaries bringing out the need for having more autonomous colleges in the country and also to treat the existing autonomous colleges differently compared to other colleges.
- (2) The usual apprehension as faced by the Colleges like stoppage of Govt. aid, pension etc. may be clarified in the above letter. The above letter may be put on UGC website and a Press Release be issued.
- (3) All the Regional Offices may be asked to take a pro-active role in promoting autonomous colleges in their region by organizing a separate meeting for the purpose.

To consider the order received from Ministry of Human Resource Development on the basis of final report of the Committee (Dr. B.L. Mungekar) regarding exemption from NET qualifications for minimum qualifications for appointment and Career Advancement of Teachers in Universities and affiliated colleges.

The Commission considered the direction received from MHRD regarding exemption from NET examination for minimum qualification for appointment of teachers. The Members expressed the view that many of the universities have advertised various teaching positions and are in the process of making selections. The Commission and the Ministry of HRD have been giving relaxation in the past all cases for the existing candidates who have successfully completed M.Phil/Ph.D and were eligible for exemption as per the existing norms. The Commission had, therefore, recommended exemption from NET for such candidates as recommended by the Mungekar Committee upto June 2009 for M.Phil candidates and June 2011 for Ph.D candidates. Such a decision would be in conformity with the past decisions of the Government.

The Members also mentioned that the research scholars already enrolled for M.Phil/Ph.D would be covered for exemption provided they complete the same by the above stipulated period.

The Members desired that their views may be conveyed to the Government for reconsideration. However, in view of the directions from the Government, the

Commission approved that the following two Regulations may be sent to MHRD for publishing in the Gazette:

- (i) UGC (Minimum Standards and Procedure for award of Ph.D. Degree), Regulations, 2008 (APPENDIX-II).
- (ii) UGC (Minimum Qualifications required for the appointment and career advancement of Teachers in Universities and Institutions affiliated to it 3<sup>rd</sup> amendment), Regulations, 2008 (APPENDIX-III)
