NOTIFICATION

CSR – In exercise of powers conferred by sub section (1) read with clause (d) of sub section (2) of section 25 of the University Grants Commission Act, 1956, the Central Government hereby makes the following rules to amend the University Grants Commission (Recruitment) Rules, 1983, namely:

1. Short title and commencement

- (1) These rules may be called the University Grants Commission (Recruitment) (Amendment) Rules, 1983.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of the Schedule

In the schedule to the University Grants Commission (Recruitment) Rules, 1983, for serial numbers 1 and 2 relating to the posts of Secretary and Additional Secretary respectively and entries relating thereto, the following shall be substitued, namely:—
