To consider and approve UGC (Conferment of Autonomous Status upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations.

The Commission considered and approved the draft UGC (Conferment of Autonomous Status upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 with the following modifications:

Clause 3.1 & 3.2: The word "courses" is replaced by "courses/programmes".

Clause 6: Wherever NAAC/NBA score is mentioned, the following terms should also be added:

"or a corresponding accreditation Grade/score from a UGC empanelled accreditation agency".

Clause 6.3: The following should be added:

"Accreditation status must be valid at the time of application".

Clause 6.4: The clause is revised as follows:

"Colleges accredited with (i) 3.51 and above in a 4 point scale of NAAC at the time of application, and (ii) colleges which have a NAAC score of 3.26 and above in two consecutive cycles and also get a similar grade in the third cycle, shall be conferred with the autonomous status without onsite visit by the UGC Expert Committee provided it also adheres to University Grants Commission's Regulations like (a) curbing the menace of ragging in Higher Education Institutions Regulations 2012; (b) UGC (Promotion of Equity in

Higher Educational Institutions) Regulations 2012; (c) UGC (Grievance Redressal) Regulations 2012, etc. in letter and spirit. The application of such colleges shall be considered as report of the Expert Committee to be presented before the Commission for consideration".

Clause 7.10: The clause is revised as "Till the extension of autonomous status is awarded by the UGC, the College shall continue to avail the autonomous status. The UGC shall also consider the interim period while granting extension of autonomous status to the College".

Clause 13.2: "Grievance Appeal Committee" may be read as "Grievance Redressal Committee".

The Commission also approved that the scheme Guidelines may be modified in conformity with the provisions of the draft Regulations. The scheme on Autonomous Colleges shall continue to be governed by the Guidelines till the Regulations are notified.

The Commission considered and approved with the suggestion that the financial assistance need to be increased.

The Commission considered and approved the University Grants Commission (Recognition and Monitoring of Assessment and Accreditation Agencies) Regulations, 2017 with the following modifications:

- (i) The Regulations shall be titled as University Grants Commission (Recognition and Monitoring of Assessment and Accreditation Agencies) Regulations, 2018.
- (ii) Clause 5.2 (1) Every application for registration as an AAA ---- through a public notification.

Provided further, that agencies set up by or under any law for the time being in force such as NAAC, NBA are outside the ambit of these Regulations.

Shall be modified as:

Clause 5.2 (1) Every application for registration as an AAA ---- through a public notification.

Provided further, that agencies set up by or under any law for the time being in force such as NAAC, NBA stand recognized for the purposes of these Regulations.

(iii) Clause 9 Allocation of an accrediting agency for accreditation.

It will be the prerogative of the HEI to opt for AAA empanelled by the UGC for assessment and accreditation.

Shall be modified as:

Clause 9 Allocation of an accrediting agency for accreditation.

HEI will give options in respect of AAA at the time of submission of application. However, AAC shall decide any AAA for a HEI considering all the relevant factors and the decision of AAC will be binding on the HEI.

(i) Clause 3 (ii) (a) It has been accredited by NAAC with a score of 3.26 and above upto 3.5; or ......

Shall be modified as:

Clause 3 (ii) (a) It has been accredited by NAAC with a score of 3.26 and above upto 3.50; or .....

(ii) The following clause shall be added at Regulation 8 with the title 'Graded Autonomy Regulations vis-à-vis other Regulations'

The provisions mentioned in the clause 4 and 5 of the Regulations i.e. dimensions of autonomy for Category-I Universities and Category-II Universities respectively, shall prevail in case of any inconsistent/conflicting provisions in the other UGC Regulations.
