## **NOTIFICATION**

GSR – In exercise of powers conferred by section 25 of the University Grants Commission Act, 1956, (3 of 1956), the Central Government hereby makes the following rules further to amend the University Grants Commission (Recruitment) Rules, 1983 regulating the method of recruitment to the posts of under secretaries in the University Grants Commission:

- **1.** (1) These rules may be called the University Grants Commission (Rrecruitment) (Amendment) Rules, 1990.
  - (2) They shall come into force on the 3rd day of April, 1989.
- 2. In the schedule to the University Grants Commission (Recruitment) Rules, 1983, for serial numbers 6 ...... to the posts of US and the entries relating to thereto, the following shall be substituted, namely:—
