1.01(a) (ii) To confirm the minutes of the meeting held on 19th July, 2012 at Indian Institute of Advanced Study, Shimla.

The minutes of the joint meeting of Commission members and UGC officers to deliberate on the XII Plan strategies were confirmed with the following amendments:

Item B: Funding of Universities

- Funding of the deemed universities may be taken up after receiving the recommendations of the committee constituted in previous meeting.
- 9. Resources generated out of ODL should not be taken into consideration while considering matching grants scheme in the ratio of 1:1.

Item D: Funding of Inter University Centres

A Committee may be constituted to study the performance of the Inter University Centres as large amounts of grants are released to these centres.

Item E: Vocation Education

The State universities located in the rural areas may be brought under funding towards NVEQF scheme for improving the skills of the students.

Item F: Revision of Schemes of Promotion of Excellence in Research and Education

A sub-committee of the Commission may be constituted to study all schemes relating to promotion of excellence.

Item I: Monitoring

All important schemes should be monitored on a regular basis. There is considerable delay taking place particularly for grant of 12-B and autonomous status to the colleges/universities, which should be minimized.

Item J: Immediate Action Points

A sub-committee of the Commission may be asked to study norm based funding to the colleges / universities also.

 Following decisions may be added under heading "Funding for Universities" at page No. 23 as Sl. No.10 and 11:

"Sl.No. 10: Funding to Deemed to be Universities may be taken up after submission of the recommendations of the Committee constituted in the previous meeting.

Sl.No. 11: The revenue generated under ODL system be not counted under the Resource Mobilization Scheme"

The Commission reiterated that, in future, whenever matters are urgent and cannot wait till the next Commission meeting and are placed for ratification of the Commission, the reasons for such an exigency may be stated in the Agenda.

appropriate allocation is made by MHRD under non-salary components to

meet out the short fall under non-salary expenditure (Non-Plan).

The Commission approved the proposal for retaining the internal

receipts by the Central Universities to cover up the short fall of non-

salary component under Non-Plan Grant for the year 2012-2013. It was

decided that the matter may be taken up with the MHRD for increasing

the allocation under non-salary components to meet out the short fall

under non-Plan non-salary expenditure.

The Commission further decided that an "Oversight Committee" may be

constituted to study the income generated and advise the UGC and the

universities in this matter. It was further decided that Smt. Anjuly Chib

Duggal and Prof. Dr. Seyed E. Hasnain may be nominated on the

Committee apart from other experts.

The Commission further decided that a communication should be sent

to all Central Universities and Delhi Colleges, which are fully funded by

UGC, clarifying the items under which non-salary expenditure can be

incurred.

2.02 To consider and approve the recommendations of the UGC Committee to develop and give Draft of the UGC (Minimum Standards and Procedure for award of M.Phil / Ph.D. Degree) Regulations, 2012.

While deferring the item, the Commission decided that a Sub-Committee of the Commission may be constituted to study the draft UGC (Minimum Standards and Procedure for award of M.Phil / Ph.D. Degree) Regulations, 2012.

2.03 To consider the amendment in respect of UGC (Minimum Standards of Instructions for the grant of the Master's Degree through Formal Education) Regulations, 2003 for giving effect to one year LLM Degree as part of restructuring of legal education.

The Commission considered the amendments in respect of UGC (Minimum Standards of Instructions for the grant of the Master's Degree through Formal Education) Regulations, 2003 for giving effect to one year LLM Degree as part of restructuring of legal education and approved the same.

2.04 To consider the request of Central Universities for extension of filling up of the XI Plan sanctioned non-teaching positions as a first charge of XII Plan.

The Commission considered the request of Central Universities for extension of time for filling up the XI Plan sanctioned non-teaching positions as a first charge of XII Plan and approved the same. The Commission further decided that the Universities should reassess their requirements at their own level and fill up only the essential positions.

<u>Chair in Banaras Hindu University on commemoration of 150th Birth</u> <u>Anniversary of Pt. Madan Mohan Malaviya Ji.</u>

The Commission considered the proposal for establishment of Pt. Madan Mohan Malviya Chair in Banaras Hindu University on commemoration of 150th Birth Anniversary of Pt. Madan Mohan Malaviya Ji and approved in principle that a Chair may be instituted at the Banaras Hindu University on the lines of Rajiv Gandhi Chair. It was decided that the Rajiv Gandhi Chair guidelines may be taken as model guidelines to be followed for establishment of Chairs in future.

It was further decided that the Banaras Hindu University may be asked to submit a detailed proposal on the model of Rajiv Gandhi Chairs.

2.07 To consider the matter relating to waiving the condition of ownership of land in the name of Mizoram University.

The Commission considered the request of the State government of Jammu & Kashmir to approve establishment of three Model Degree colleges in three carved out districts of the State and approved the same.

4.01 To consider the guidelines for composition of subject panels in various disciplines.

This was deferred. It was decided that the Commission members would send their comments to the UGC and that the matter would be placed before the Commission for consideration at its next meeting.

4.02 To consider the proposed emoluments for payment to the functionaries engaged in conduct of UGC-NET.

The Commission considered the proposed increase in emoluments for payment to the functionaries engaged in conduct of UGC-NET and decided that norms be evolved for payment of remuneration to the various functionaries. The Chairman, UGC was authorized by the Commission to decide on the norms for the above.

The Commission further decided that TA/DA norms followed by the Commission may be reviewed keeping in view the DST/CSIR/DRDO norms.

4.03 To consider the issue of provision of two seats under supernumerary quota in the universities and colleges.

The Commission considered the issue of provision of two seats under supernumerary quota in the universities and colleges and approved creation of two supernumerary seats in all institutions which are recognized under section 2(f) and 12 (B) of the UGC Act for general courses. It was noted that AICTE was taking similar action for technical courses. It was further decided that fellowships for students, who have already been admitted this year, may be approved even if they are more than two per institution.

The Commission further decided that a list of universities and colleges included under section 2(f) and 12(B) in the country may be supplied to AICTE, which has been designated by the MHRD to administer this scheme through a dedicated website.

SECTION-5 (GRANTS TO UNIVERSITIES AND COLLEGES)

5.01 To consider the compliance report submitted by Eternal University (Private University) Baru Sahib, Distt. Sirmour (Himachal Pradesh) in respect of the observations/suggestions given by UGC Expert Committee which visited the Private University on 17th to 19th December, 2010 to assess fulfillment of criteria in terms of programmes, faculty, infrastructural facilities, financial viability, etc., as laid down from time to time by the UGC and other concerned statutory bodies.

The Commission considered the compliance report submitted by Eternal University (Private University) Baru Sahib, Distt. Sirmour (Himachal Pradesh) in respect of the observations/suggestions given by UGC Expert Committee and observed that there are many glaring

inconsistencies in the compliance report. The Commission decided that another Expert Committee may visit this university to verify the claims of the university.

To consider the release of funds to National University of Educational Planning and Administration (NUEPA) (Deemed to be University), New Delhi for establishment of Centre for Policy Research in Higher Education.

The Commission considered the release of funds to National University of Educational Planning and Administration (NUEPA) (Deemed to be University), New Delhi for establishment of "Centre for Policy Research in Higher Education" and sought a clarification from Secretary, MHRD whether the letter dated 19th July, 2012 from Joint Secretary, MHRD may be treated as a direction from the Government to which the Secretary, MHRD clarified that it may be taken as the direction. Since such a Centre does not exist anywhere in the country and there is a need for such a Centre, the Commission agreed that the "Centre for Policy Research in Higher Education" at NUEPA may be supported by the UGC, even though NUEPA is fully funded by the MHRD directly. However, the Commission decided that the proposal may be evaluated with the help of an Expert Committee. The Commission authorized the Chairman, UGC to constitute an Expert Committee for on-the-spot evaluation of the proposal and take a final decision in the matter which may be placed before the Commission.

The Commission considered the report of the UGC Expert Committee constituted to assess the proposal of Gandhi Institute of Technology and Management (GITAM) (Deemed to be University), Visakhapatnam, Andhra Pradesh to start off-campus at Nagadenahalli, Dodaballapur Taluk, Bengaluru Rural District, Karnataka and approved the same subject to review of the off-campus centre by the UGC biennially for six years and subsequently after five years. It was further decided to send the recommendations of the Commission to M/HRD for its approval.
